

Letter of Commitment

General conditions of students' presence in Iran University of Medical Sciences

1- The language of instruction for master's and Ph.D. programs is either English or Persian (as determined by the department). All fellowship, specialty, and subspecialty programs are taught in Persian, and the university holds no responsibility for applicants' lack of proficiency in Persian.

In this regard, the Iran University of Medical Sciences announces its readiness to offer Persian language educational services at various levels (beginner, intermediate, advanced). Students can enroll in these courses after paying the approved tuition fees and completing the placement test.

* The student must have their academic certificate verified and submitted to the Education Department by the end of the first semester. Failure to do so will result in expulsion from the university, and financial penalties will be applied following the university's financial regulations.

* Have the original academic certificate translated by an official translation office and stamped by the Ministry of Foreign Affairs (Iran). Then, visit the Iranian Consulate in the home country to verify the academic certificate and obtain a tracking code.

*Starting from the first semester of the 1403-1404 academic year, all students in all programs must take the Persian language proficiency test before graduation.

Students must submit their valid English language proficiency certificate to the academic office no later than before the start of their first semester.

2- It is not possible to change between university branches, as well as change the times and class groups.

3- Before registration, confirm for the approval of Iran University of Medical Sciences degrees in the Ministry of Health or the Ministry of Higher Education of your country; university has no responsibility for the approval or non-approval of the university degrees in your country.

4- The university is not responsible for the issuance or non-issue of visas by the Ministry of Foreign Affairs, as well as the duration of visa issuance.

5- The applicant undertakes to cancel the Saorg code from other universities before final registration in this university.

6- The applicant is required to pay the full year's tuition within 10 days after the acceptance letter is issued, otherwise the acceptance will be canceled.

7- In case of withdrawal after obtaining a student number, the tuition fee for the first semester is non-refundable.

8- Students are required to comply with all ethical standards according to the rules and regulations of the Islamic Republic of Iran and must always have a simple and well-dressed in worthy of the university. In case of non-compliance, issue will be raised and decided in the disciplinary committee.

9-Regarding the introduction of Iran University of Medical Sciences as No Smoking university; The student is obliged to comply with all the rules and regulations according to the guidelines of the no-smoking university regulations.

10-Student insurance is mandatory for all students and the cost is in charge of students.

11- The applicant commits to canceling any Saorg code received from other universities before finalizing their registration at this university.
